



PARTNERSHIP AGREEMENT

Partnership Agreement Nation Studios

This agreement will be active from the time of application. Nation Studios ("TV Nation Studios"), NSTV ("we", "network") we are willing to help you increase your relevance and revenue from your YouTube channel and create good content for it. This document ("Agreement") sets forth the terms of the bond between us and his (s) channel (s), along with all the videos and other content or going to these channels (referred to herein as "Content") –

After agreeing to the terms referred to above, will the legal and pagamentos terms:

- Revenue sharing: a share of 70% (higher or lower than this value can be pre-determined and subsequently amended) Revenue received by us solely in connection with its canals will be granted.

- You will be paid for NSTV through your PayPal account payments made to you will be sent between day 7-10 after 40 days (forty days) after you join our network.

What will you do for our network:

You agree to give their best to produce good content and sends it regularly (s) is (s) channel (s) on YouTube. As you might expect, it is very important that you produce according to the YouTube regulations on content: using music or movies, including remixes and edits protected by copyright is not allowed. YouTube is strict about it and we do not want your uploads can cause conflict between us and the copyright holders.

You must have full contents of their authorship, funded by you till the time duration of these terms. However, we have full authority to delete any Content that violates any law or regulation (including rules and regulations set forth by YouTube or Google) that we believe may infringe the intellectual property rights of any person, or it could have a negative impact on our network and / or business and / or reputation ("inappropriate Content"). Occasionally, they may present, at our discretion, the content on our channels "hub" to promote it. To make this possible, you grant us a non-exclusive license to distribute and modify its content for promotional purposes in our "Hub" channels.

If necessary we may ask the partner to use our brand or Logos. To do whatever is asked the partner may be promoted through our network of integrated ads to Google "Adwords" and Adsales YouTube channels as listed in partners our network.

What the Nation Studios network tools now provide you with the following:

- Panel to use the Metrics partners with Views and Earnings within the network;
- Audio library of over 100,000 (one hundred thousand) tracks Audios for utilizações in your videos or for any other purposes;

- The network will give you the option to integrate new channels with us and be paid with a percentage of 10% (ten percent) of all income generated monthly for any channels obtained through your link; * (If you accept our feramenta search and connection of new channels, we provide you with a corporate email network termination at the Domain);

By the end of this agreement, you give us each of the following rights:

a) The exclusive right to sell, manage, and report all advertising inventory on your (s) channel (s) and contents;

b) The exclusive right to collect the revenue generated by your (s) channel (s) and contents;

c) The nontransferable, worldwide, royalty-free, nonexclusive license to use your name, likeness and voice as well as to display their brands and logos in connection with the promotion Network, the individual channels on the network and / or its channels and / or content. Notifications YouTube: Will you accept the invitation to join the network in your control panel from YouTube, and to accept, understand that you will link your channel to our network, and the whole monetization for your YouTube channel to be sent directly to us;

Fraud Action: You will not, and will not allow / enable / authorize any third party to generate automated, fraudulent or otherwise invalid Advertising Actions. If we believe it is suspicious and / or determined to be that related to the content on your (s) Channel (s) 'fraud action, "" click fraud "or" fraud impression, "or any other kind of fraud activity ("Action fraud"), we may withhold any payments otherwise payable to you, and shall be entitled to recover from you any payments previously made that are attributable to the fraud, and may, at our sole discretion, suspend or terminate this Agreement.

Representations and Warranties:

You represent and warrant that:

(i) You state that you have 18 years of age or older, or an emancipated minor, or possess legal parental or guardian consent, and are fully able and competent to enter into the terms of this Agreement, and to respect and comply with all its terms together with any terms of service that we may provide from time to time. In any case, you affirm that you have more than 13 years, since the network is not intended for children under 13 years.

Miscellaneous:

NSTV can possess and without any reason at all terminate this agreement. If you are under 13 years of age, then please do not join the network, (ii) you are the owner of all rights for all aired on its channels, content, (iii) you have the right and power to license and / or sell such Content, (iv) or any Content, or the use of its channels infringe the rights of third parties, (v) you

have not given anyone else the right or authority to act on its behalf in any manner that may conflict with any rights on the part of this Agreement, (vi) and you must comply with each and every word from Google or YouTube, rules and regulations from time to time.

Indemnity:

You agree to indemnify and hold us and our shareholders, directors, officers, employees, agents, subsidiaries and affiliates, from and against any civil and criminal rights, liabilities, judgments, fines, and all costs, expenses (including attorneys' fees) incurred in connection with your breach of the representations, warranties and covenants of this Agreement and / or development, production, distribution and / or other exploitation of the Content.

This provision shall survive termination of this Agreement.

Disclaimer / Remedies:

WE ARE NOT RESPONSIBLE FOR ANY LOST PROFITS OR DAMAGES, punitive or consequential acts arising IN CONNECTION WITH THE SUBJECT MATTER OF THIS AGREEMENT. YOU irrevocably waive all rights to seek injunctive relief FAIR or otherwise. And agree to limit your claims to claims for monetary damages (if any). OUR TOTAL LIABILITY FOR ANY CAUSE OF ACTION ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT shall not exceed the amounts paid to You under this AGREEMENT AS OF THE DATE OF THE CLAIM.

In case of violation of the agreement, we will notify you give him a chance to remedy the situation. However, in the case of a material breach that you understand that there may be no other option for us, then cancel the partnership and withdraw its channel our network. By submitting this form you confirm that you are of legal age and that you have the approval of a parent or guardian. This agreement is valid for a period of (1 year) from the point of approval NSTV. The agreement will further expand by (1 year) at the end of the contract period if not canceled by the (partner) within a period of 60 days prior to termination.
